SUBMISSION OF CERTIFICATION FOR LISTING

INSTRUCTIONS: If you hold a valid Laser Certification from a recognized organization then you may be listed on the International Laser Certification Registry when you submit the valid document and pay the required fee for listing. This database is used by the public to search for providers and by regulatory authorities to confirm Certifications. A training certificate by itself is NOT a laser certification. Recognized laser certification organizations include the *NCLC, ABLs, ADA, BLS and SCMHR*. The information you provide below will be entered into the file for the Laser Registry, but only your general location and no contact information will be seen unless you login to your account and change your public visibility so that others may see as much or as little of you as you decide. Your type of Certification and expiration date will be displayed in all cases.

REGISTRATION FEE is \$35 per year for listing. Most Certifications are good for three years and you would be charged only \$95 total for the three years of your active Certification like NCLC members. If you submit with less than three years remaining on your active certification you would be billed for \$35 per year and partial year until your expiration. You may make payment online at https://lasertraining.org/NCLC/NCLC_Payments.php and just state your name and what it is for, or alternatively request that we invoice you; A quickbooks invoice will be sent via email.

DOCUMENTS: Please attach a copy of your valid Certification Certificate that is current. We will show the expiration date listed on it when posted on the ILCR™ website. Please also write in the original issue date of the Certification Certificate below on this form. Your registry file that you can log in to will have a folder to retrieve that certificate if you need.

RENEWALS: A few months prior to the expiration of your valid Certification, the ILCR™ website will send you automated reminders of your renewal (renew both with the originating organization and the ILCR™). Just send back a copy of your renewed Certificate and payment of \$95 if it is for three years to renew your listing in the Registry.

NOTE: All Certifications issued through the National Council on Laser Certification will be automatically listed in this Laser Registry at no additional charge. You'll also receive automated reminders for renewals once every three years. You do NOT need to use this form if you have an NCLC Laser Certification.

We will verify your Certification prior to listing.
